

**Resolution of the County Board
of
Kankakee County, Illinois**

**RE: AMENDED - COMBINED ANNUAL BUDGET AND APPROPRIATION
ORDINANCE FOR KANKAKEE COUNTY, ILLINOIS 2009-2010 FISCAL YEAR**

WHEREAS, at its November 18, 2010, meeting the Finance Committee of the Kankakee County Board determined the amount of money estimated and deemed necessary to meet and defray the legal liabilities of necessary expenses that were incurred from December 1, 2009, through November 30, 2010, and listed their specific detailed budget adjustments by itemizing county expenditures for the 2009-2010 general fund budget; and,

WHEREAS, the 2009-2010 fiscal year began December 1, 2009, and ended November 30, 2010, and it was determined at the November 18, 2010, Finance Committee Meeting, that new grants weren't previously identified when the 2009-2010 budget was adopted under resolution 2010-11-22-159, and a revenue and expense budget amendment for the general fund totaling \$821,846 in new revenues and \$821,846 in new expenditures should have been included.

BE IT ORDAINED by the Kankakee County Board that the attached recommended budget amendment is hereby adopted and appropriated as the Amended-Combined Annual Budget and Appropriation Ordinance for Kankakee County, Illinois for the fiscal year beginning December 1, 2009, and ending November 30, 2010.

BE IT FURTHER ORDAINED by the Kankakee County Board that the amounts listed as amendments to the 2009-2010 budget amounts for the fiscal year from December 1, 2009, through November 30, 2010, are hereby identified as new revenue and expense in the amount of \$821,846 for the purposes herein specified, as may be authorized by law. Supporting documents (Exhibit A) are made a part of this resolution and incorporated herein by reference.

BE IT FURTHER ORDAINED that the amended budget herein made and ordained be known as the Amended Combined Budget and Appropriation Ordinance of Kankakee County, State of Illinois, for fiscal year 2009-2010 and shall reflect the amendment as evidenced by Exhibit A.
