NOW, THEREFORE, BE IT RESOLVED, by the Kankakee County Board of Kankakee County, Illinois, that the above listed days be observed as legal holidays by the County of Kankakee for calendar year 2025; and in addition to the foregoing holidays, the chief judge in each circuit in Illinois may declare a court holiday when the court facilities would otherwise be closed for the observance of a holiday not listed above.

NOW, THEREFORE, BE IT FURTHER RESOLVED, these additional observances shall be limited to only those situations in which both court security is unavailable and all county government offices are closed.
